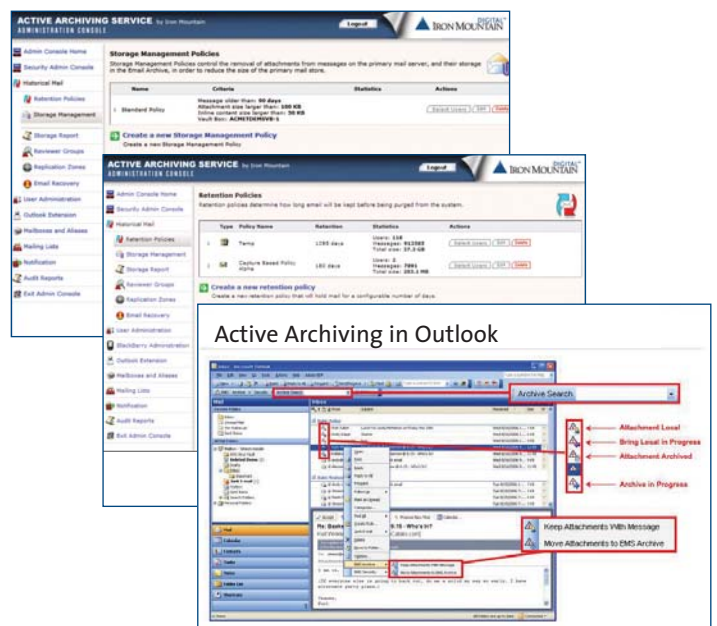

Storage Management/Mailbox Management. The Active Archiving Service is a cost-effective managed service that is fully integrated with Microsoft® Exchange®, allowing administrators to set granular storage management policies. When messages are archived, these policies can remove attachments from local Exchange servers while providing full access via Outlook or a web browser.



Referencing attachments stored in the archive reduces the load on email servers by 80% and provides relief from Inbox quotas.

This can decrease Exchange data stores by as much as 80%! The results include more productive users, dramatically decreased backup, recovery and maintenance windows, and improved email reliability.

Records Retention & Policy Compliance. The Active Archiving Service allows organizations to set granular retention policies, such as by user, department, email server or location, streamlining compliance with corporate records retention requirements. The service also provides auditing of policy changes and support for legal holds.

eDiscovery. The Active Archiving Service makes it easy for legal counsel and other authorized users to search selected mailboxes or across an entire population using any search criteria. The service provides rapid, full-text search and retrieval of all email and attachments and the ability to export results to leading legal review and case management tools.
